- OT** – Overtime
- SA** – Shift Allowance
- E** – Earnings for relevant payment period
- D** – Deductable amount
- PIAWE** – Pre-Injury Average Weekly Earnings (OE + OT + SA + D)
- PIAWE** (post 52 weeks) – after 52 weeks of entitlement, PIAWE* excludes OT and SA (i.e PIAWE* = OE)
- MAX** – Maximum Weekly Amount as specified in the Act.
